Rough start to January ranks as one of worst ever

▶ U.S. stocks (S&P 500 Index) declined 6.4% during the first half of January, one of the worst calendar-year beginnings on record.¹

The worst January stock market performances typically occurred during periods of significant economic turbulence

▶ Of the five worst January declines since 1926, four of them happened during or close to an economic recession.

However, subsequent to the five worst January performances since 1926, the stock market generally recovered to post positive returns

▶ In all five instances, stocks finished higher one year after the dismal January, averaging a 12% gain over the next 12 months.

▶ During the two years after the poor January performances, stocks rose more than 30% in four out of the five instances.
